"Rider and Horse Divisions"

Rider Divisions: (Enter one Rider Division)

- Youth (18 years old and/or under)
- Novice (open to rider that has never placed in any judged trail ride)
- Chicken Little (for rider entering their first judged trail ride)
- Open (for riders that have placed in a judged trail ride - 19 years old and above)

Horse Divisions: (Enter one Horse Division)

- Novice (open to any horse that has never placed in any judged trail ride)
- Chicken Little (for first time participation of a horse)
- Open (for horses that have placed in a judged trail ride)
- Senior (for horses 18 years and older)

Time: JTR Registration begins at 9:30. First Rider out at 10:00, last Rider out at 12:00. \$35 per ride, Individual scores. No riders out past 2:30. **Helmets are required on all riders. Youths must be accompanied by an adult.**

I understand that my participation involves all inherent risks associated with the dangers and conditions which are an integral part of equine activities, including, but not limited to, the propensity of equines to behave in ways which may result in injury, harm or even death to humans or other animals around or near them; the unpredictability of equine reaction to sounds, sudden movements, smells, and unfamiliar objects; persons or other animals; hazards related to surface and subsurface conditions; collisions with other equines or objects; and, the potential of a participant to act in a negligent or unskilled manner which may contribute to injury to the participant or others, including failing or inability to maintain control over the animal. By participating in this activity I agree to assume responsibility for those risks, and I release and agree to hold harmless the activity organizer, organizing committee, officials, the FCDA/FCEA, their officers, agents, employees and the volunteers assisting in the conduct of this FCDA/FCEA activity and the owners of any property on which it is to be held, from all liability for negligence resulting in accidents, damage, injury or illness to myself and to my property, including the horse(s) which I may ride.

I understand and agree that the organizer of this activity has the right to cancel this activity; to refuse any entry or application; to require and enforce the wearing of safety or other attire and the conduct of riders, horses, and visitors; and to prohibit, stop or control any action during the activity deemed by the organizer to be improper or unsafe.
